

Terms and Conditions of Participation

Every runner who submits his/ her pre-registration form is doing so voluntarily, agrees and fully commits to follow the rules and conditions of the event, as mentioned below.

General Terms & Conditions

- Eligibility to register and participate in the race have runners who meet the specific conditions of participation as written in the “About the race” section of the website www.yianniskouros.com and are in the proper physical and mental health, that is required in such an extreme event.
- Upon completing the pre-registration form, runners automatically accept and consent that they participate under their own responsibility regarding their health condition. Runners are required to provide a recent medical certificate certifying their excellent physical condition and allowing participation in the specific race.
- Runners participate in the race, knowing that the provided medical coverage may not be available at all times, nor at any race point.
- The age prerequisite to participate in the “Pheidippeides’ Athlos” Ultra Marathon Race is 20+ years old and it concerns only able-bodied runners.
- The “Pheidippeides’ Athlos organizing team has the right to change the event’s schedule, the terms and conditions regarding participation and staging of the event, without prior notice, by posting such a decision on the website of the event.
- The photos and videos of the participants may be uploaded on the website of the Official Photo Agency of the event, or on a website dedicated to the event and they may be visible by the public and remain as such without time limitation, according to the contractual obligations of the organizers. Any photographs may be purchased online following the event, through the website of the event's Official Photo Agency.

Terms & Conditions of Registration

- Only runners that have officially and in time registered for the event can participate in the Pheidippeides’ Athlos race.
- The Pheidippeides’ Athlos event takes place the day and time that has been announced as such, regardless of weather conditions. Only in cases of exceptional circumstances or other force major incident, the organizer team of the event has the right to decide on the postponement of the start time or the cancellation of the event, depending on the current conditions. In such cases, the registration fee is not refunded to the registered runners.
- The personal data declared by the participant upon submission of pre-registration form are true and correct. In case the entry form is submitted by a third party, it is granted that the participant consents to his/her personal data being given to Pheidippeides’ Athlos organizing team of the event by the third party.

- Registration to the Pheidippeides' Athlos ultra marathon race requires the completion of the pre-registration form first and is considered final only after the e-mail approval sent by the organizers to the applicant.
- The organizing team has the right to suspend, or close registrations without prior notice, by posting such a decision on the website/s dedicated to the event.
- A registration is considered valid on the condition that it has been successfully submitted and that the registration fee, as determined on the date of registration, is successfully paid, while the amount of the registration fee has been credited to the organizers' accounts.
- Registration fees that have not been paid at least three (3) weeks prior to the event are cancelled with no prior notice.
- Registrations, which for any reason do not follow the rules and conditions of the event, may be cancelled by the organizing team without prior notice
- Changes on confirmed registrations (runners' replacement) are only possible upon relevant request to the organizing team. The replacement runner will only be accepted if he/she meets the same criteria of the previous registered runner.
- Cancellations are supported strictly up until **three (3) weeks before the date of the race**. Cancellation requests after this time period are not accepted and there is no possibility for refunds. Any kind of cancellation request should only be sent to the following email: yianniskouros@yahoo.com. In all cases of cancellations requests sent up until the above date to the above email, the registration fee is refunded to the applicant, after the **deduction of fifty euro (€50)** as handling fees, regardless the reason of cancellation. Donations are non-refundable.
- Changes regarding the selected t-shirt size of the runner, or any other race products, may be feasible upon request and only if they are available.

Terms & Conditions for Race Bib and Kit Collection

- Race bibs and kits are personally collected by the registered runners themselves and only from the event's Runners' Center during the days and hours announced. The registered runner needs to present a valid identification document (ID card, passport etc.) and any other documents indicated by the organizing team. A registered runner may authorize another person to collect his/her race bib on his/her behalf from the event's Runners registration Center, as mentioned above, by presenting a copy of the ID card or other legal identification document (for example passport, driving license) of the registered runner.
- Race bibs and kits are not sent anywhere, under any circumstances, either by regular mail or any other way to their rightful runner, before or after the operating days and hours of the event's Runners' Center. Race bibs and kits that are not properly collected during the operating days and hours of the event may not be sent or collected under any circumstances thereafter.
